ABOUT THE ANNUAL PHA PLAN REVIEW AND PUBLIC COMMENT PROCESS

Each year, Housing Catalyst and the Larimer County Housing Authority prepare Annual Public Housing Agency (PHA) Plans to share information about housing programs, policies, and planned activities for the upcoming year. The PHA Plan provides an opportunity for residents, program participants, landlords, community partners, and members of the public to review our planned initiatives and provide feedback.

As a Moving To Work (MTW) Demonstration Program agency, Housing Catalyst also submits an annual MTW Supplement to the U.S. Department of Housing and Urban Development (HUD). The MTW Supplement describes proposed MTW activities, program changes, and strategies designed to meet local housing needs, increase administrative flexibility, and support the effective use of federal housing resources.

In addition, Housing Catalyst periodically updates its Housing Choice Voucher Administrative Plan, which outlines the policies and procedures used to administer rental assistance programs in a manner consistent with HUD requirements and local goals and objectives.

The public comment period, Resident Advisory Board meetings, and public hearing provide opportunities for residents and the community to learn about proposed changes, ask questions, and share feedback before the plans are submitted to HUD for approval.

Housing Catalyst values community input and encourages residents, stakeholders, and the public to participate in this review process.

Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations including PHA Plan Elements that Have Changed

Acting on behalf of the Board of Commissioners of the Public Housing Agency (PHA) listed below, as its Chairperson or other authorized PHA official if there is no Board of Commissioners, I approve the submission of the ___ 5-Year and/or ___ Annual PHA Plan, hereinafter referred to as “the Plan,” of which this document is a part, and make the following certification and agreements with the Department of Housing and Urban Development (HUD) for the PHA fiscal year beginning ____, in which the PHA receives assistance under 42 U.S.C. 1437f and/or 1437g in connection with the submission of the Plan and implementation thereof:

1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located (24 CFR § 91.2).
2. The Plan contains a signed certification by the appropriate State or local official (form HUD-50077-SL) that the Plan is consistent with the applicable Consolidated Plan, which includes any applicable fair housing goals or strategies, for the PHA's jurisdiction and a description of the way the PHA Plan is consistent with the applicable Consolidated Plan (24 CFR §§ 91.2, 91.225, 91.325, and 91.425).
3. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Resident Advisory Board or Boards in developing the Plan, including any changes or revisions to the policies and programs identified in the Plan before they were implemented, and considered the recommendations of the Resident Advisory Board (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the way the Plan addresses these recommendations.
4. The PHA provides assurance as part of this certification that:
 - i. The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
 - ii. The changes were duly approved by the PHA Board of Directors (or similar governing body); and
 - iii. The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours. Where possible, PHAs should make documents available electronically, for public inspection upon request.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment. The PHA ensured all notices and meetings provided effective communication with persons with disabilities and further provided meaningful language access for persons with Limited English Proficiency (LEP).
6. The PHA certifies that it will carry out the public housing program of the agency in conformity with Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d-2000d—4), the Fair Housing Act (42 U.S.C. 3601-19), Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794), Title II of the Americans with Disabilities Act (42 U.S.C. 12101 et seq.), the Violence Against Women Act (34 U.S.C. § 12291 et seq.), and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs. In addition, if it administers a Housing Choice Voucher Program, the PHA certifies that it will administer the program in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans with Disabilities Act, the Violence Against Women Act, and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs.
7. The PHA will affirmatively further fair housing, in compliance with the Fair Housing Act, 24 CFR § 5.150 et seq., 24 CFR § 903.7(o), and 24 CFR § 903.15, which means that it will take meaningful actions, in addition to combating discrimination, that overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected characteristics. Specifically, affirmatively furthering

fair housing means taking meaningful actions that, taken together, address significant disparities in housing needs and in access to opportunity, replacing segregated living patterns with truly integrated and balanced living patterns, transforming racially or ethnically concentrated areas of poverty into areas of opportunity, and fostering and maintaining compliance with civil rights and fair housing laws (24 CFR § 5.151). Pursuant to 24 CFR § 903.15(c)(2), a PHA's policies should be designed to reduce the concentration of tenants and other assisted persons by race, national origin, and disability. PHA policies should include affirmative steps stated in 24 CFR § 903.15(c)(2)(i) and 24 CFR § 903.15(c)(2)(ii). Furthermore, under 24 CFR § 903.7(o), a PHA must submit a civil rights certification with its Annual and 5-year PHA Plans, except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document. The PHA certifies that it will take no action that is materially inconsistent with its obligation to affirmatively further fair housing.

8. For PHA Plans that include a policy for site-based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module and/or its successor system: the Housing Information Portal (HIP) in an accurate, complete and timely manner (as specified in PIH Notice 2011-65);
 - The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of a site-based waiting list would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such a waiting list is consistent with affirmatively furthering fair housing; and
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR 903.7(o)(1).
9. The PHA will comply with the prohibitions against discrimination based on age pursuant to the Age Discrimination Act of 1975.
10. In accordance with the Fair Housing Act, the PHA will not base a determination of eligibility for housing on actual or perceived sexual orientation, or marital status and will not otherwise discriminate because of sex (including sexual orientation).
11. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, 'Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped' for people with physical disabilities.
12. The PHA will comply with the requirements of Section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
13. The PHA will comply with the acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implement the regulations at 49 CFR Part 24 as applicable.
14. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
15. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
16. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
17. The PHA will keep records in accordance with 2 CFR 200.302 and facilitate an effective audit to determine compliance with program requirements.
18. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
19. The PHA will comply with the policies, guidelines, and requirements of 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Financial Assistance, including but not limited to submitting the assurances required under 24 CFR §§ 1.5, 3.115, 8.50, and 107.25 by submitting an SF-424, including the required assurances in SF-424B or D, as applicable.

20. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
21. All attachments to the Plan have been and will continue to always be available at all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA and, where possible, should be made available for public inspection in an electronic format.
22. The PHA certifies that it is following all applicable Federal statutory and regulatory requirements, including the Declaration of Trust(s).

Goal 1: Provide affordable housing of the highest quality through effective property operations and asset management

- Housing Catalyst completed the redevelopment of the Village on Impala in 2025, transforming the former public housing site into a thoughtfully designed affordable housing community featuring 86 affordable homes through the renovation of 24 duplex units and construction of four new apartment buildings. This strategic redevelopment effort continues the agency's commitment to preserving and improving affordable housing, creating healthy, sustainable communities while maintaining long-term affordability.
- The Village on Impala redevelopment included a new clubhouse and leasing office, enhanced green space, improved pedestrian and bicycle connections, and sustainable design features including Energy Star standards, electric vehicle charging, solar energy, and water-wise landscaping.

Goal 2: Increase supply of affordable housing

- In 2025, Housing Catalyst completed construction of 62 new affordable apartments and renovated 24 duplex units at the Village on Impala. This redevelopment more than doubled the site's previous housing capacity, securing 86 high-quality affordable homes for Fort Collins residents.
- Housing Catalyst secured a \$35.5 million development package for the Village on Eastbrook, including federal and state Low-Income Housing Tax Credits, tax-exempt bonds, and taxable bond financing to support construction of 73 new affordable apartments in southeast Fort Collins.

Goal 3: Increase housing opportunities for residents of Fort Collins and Larimer County

- Housing Catalyst administered approximately \$21.6 million in Housing Assistance Payments to local families during 2025 and administered 1,696 housing vouchers throughout Northern Colorado.
- Through Housing Catalyst's Moving to Work (MTW) landlord incentive initiative, 13 local property owners received leasing bonuses designed to increase landlord



- participation in the Housing Choice Voucher (HCV) program and expand housing choice for voucher holders.
- Housing Catalyst continued implementation of MTW program flexibilities designed to improve operational efficiency while maintaining participant access to safe and affordable housing, including continued implementation of biennial reexaminations and ongoing evaluation of payment standards to support long-term program sustainability.
- Housing Catalyst proactively managed HCV funding through continuous financial monitoring, expenditure forecasting, and program evaluation to maximize housing assistance while responding to changing federal funding conditions.
- In July 2025, the U.S. Department of Housing and Urban Development (HUD) and the U.S. Department of Veterans Affairs (VA) awarded Housing Catalyst funding for 10 additional Veterans Affairs Supportive Housing (HUD-VASH) vouchers, increasing the agency's total HUD-VASH allocation to 209 vouchers.

Goal 4: Enhance social and economic wellbeing for residents

- Housing Catalyst supported 176 participants through the JumpStart Family Self-Sufficiency program as they worked toward their educational, employment, and financial goals during 2025.
- A total of 141 Permanent Supportive Housing (PSH) residents lived in stable homes with wraparound supportive services designed for individuals with disabilities who had experienced chronic homelessness.
- Housing Catalyst continued to provide housing stability and resident services that support long-term self-sufficiency and improved quality of life for residents across its affordable housing portfolio.

Goal 5: Achieve excellence in business operations

- Housing Catalyst continued to improve operational effectiveness through technology, process improvements, and sound financial management across its affordable housing and rental assistance programs.
- Housing Catalyst received the Government Finance Officers Association's Certificate of Achievement for Excellence in Financial Reporting for the twelfth consecutive year. This certificate recognizes the agency's commitment to transparent and comprehensive financial reporting.
- Housing Catalyst maintained an AA- credit rating from S&P Global, demonstrating continued financial strength and organizational stability.





Goal 6: Build community support for affordable housing

- Housing Catalyst celebrated the grand opening of the Village on Impala with federal, state, county, and local partners, highlighting the importance of collaborative investment in affordable housing and neighborhood revitalization.
- Housing Catalyst continued to partner with public agencies, financial institutions, developers, and community organizations to advance affordable housing opportunities throughout Northern Colorado, including the successful financing of the new Village on Eastbrook development.
- Housing Catalyst continued outreach and engagement with property owners participating in the HCV program, supporting landlord recruitment and retention efforts through MTW landlord incentive initiatives.
- Housing Catalyst's affordable housing investments generated an estimated \$510 million in economic output, supported approximately 405 jobs annually, and contributed \$296.5 million in value added to the Larimer County economy.

Goal 7: Advance Housing Catalyst as an employer of choice

- Housing Catalyst continued to invest in employee development by supporting professional growth, innovation, and collaboration across all departments while advancing the agency's mission of providing affordable housing and rental assistance. This included an employee scholarship program, wellness opportunities, and the introduction of a reduced work week for qualifying employees.
- Through continued organizational excellence, Housing Catalyst maintained strong financial stewardship, high-quality operations, and a workplace culture focused on serving residents and the Northern Colorado community.
